| <p>1. Due to safety and security reasons cruise ship passengers are not permitted to walk to / from the entrance gate of the Westports cargo terminal.</p> <p>2. Taxis will be made available at the wharfside to facilitate passengers' journey to popular destinations. No shuttle buses or taxi service will be available from wharfside to terminal gate. Shuttle buses will only be provided for passengers returning from Westports terminal gate to the cruise vessel.</p> <p>3. Passengers making their own transportation arrangements must notify the terminal through the ship's agents prior to arrival at port including details of the vehicles. Failure to do so will result in vehicles being denied entry to the wharf area.</p> | <p>1.
