

**LAWATAN KERJA KE PELABUHAN KLANG OLEH
YB. MENTERI KEWANGAN II DAN YB. MENTERI PENGANGKUTAN
PADA 8 MAC 2018 (KHAMIS)**

8 MAC 2018 - Satu lawatan kerja ke Pelabuhan Klang yang diketuai oleh YB. Datuk Seri Johari Abdul Ghani, Menteri Kewangan II dan YB. Dato' Sri Liow Tiong Lai, Menteri Pengangkutan telah diadakan pada 8 Mac 2018 bagi meninjau operasi di pelabuhan, terutamanya melibatkan prosedur kastam.

**WORKING VISIT TO PORT KLANG BY
YB MINISTER OF FINANCE II AND YB MINISTER OF TRANSPORT ON
8 MARCH 2018 (THURSDAY)**

A working visit to Port Klang led by YB Datuk Seri Johari Abdul Ghani, Minister of Finance II and YB Dato' Sri Liow Tiong Lai, Minister of Transport was held on 8 March 2018 to review the port operations, mainly involving customs procedures.
