PORT KELANG AUTHORITY GENERAL MANAGER CIRCULAR NO. 19/2021

REEFER CONTAINER SERVICE CHARGE IN PORT KLANG

We refer to the interpretation requested by Port Users on the above subject matter.

2. Please be informed that Port Users shall pay the reefer container service charge prescribed in Port Kelang Authority (Scale of Rates, Dues and Charges) By-Laws 2012 which came into effect beginning 3 May 2012 as follows:

Description	20' in length (RM)	40' in length (RM)	Exceeding 40' in length (RM)
(a) Plugging or unplugging reefer containers on board ship;	15.00	15.00	15.00
(b) Connecting, disconnectng and monitoring reefer containers at the container yard including electricity consumption (per shift);	35.00	50.00	60.00
(c) Inspection of empty reefer containers prior to delivery to shipper or prior to loading on board ship	70.00	70.00	70.00


4. The reefer container service charges shall be billed to the Shipping Companies / Box Operators for the first 9 shifts (3 days) from the time of reefer container discharge and thereafter the said charges shall be billed to the Consignee / Forwarding Agent.
